- > To work to support the development of the children within the Birth to Three Framework or the Foundation Stage Guidance.
- ➤ To manage the children's behaviour and routines in line with the First Steps Bath policies and guidelines.
- ➤ To work within a key person system and to adhere to the community nursery guidelines on the role of the keyworker.
- ➤ To maintain objective, accurate and up to date records that identify the children's individual needs, abilities, and progress, and use these as a focus for future planning, following the special educational needs code of practice.
- To work in respectful partnership with parents, carers, and other professionals always.
- ➤ To work within the community nursery's First Steps Bath health and safety guidelines and undertake specific tasks related to the safety and hygiene of the children and the nursery.
- ➤ To work within the community nursery's First Steps Bath Safeguarding and child protection policy and procedures, inclusion policy and confidentiality policy.
- ➤ To share tasks necessary as part of the general upkeep, tidiness and cleanliness of the community nursery environment and resources, and which contribute to the general well-being of the team.
- To participate in and contribute to regular staff meetings, appraisals and training including INSET days to improve skills and knowledge and develop a positive attitude that enhances practice.
- > To maintain a high level of professionalism, both inside and outside the nursery.
- ➤ To undertake any other tasks, as requested by the management team, that are necessary for the smooth running of the nursery and the welfare of the children in its care.
